**NLASW Professional Development Fund
Application Form**

General Information

- The NLASW Professional Development Fund provides financial sponsorship for current NLASW members to attend professional education events that meet the criteria established by the Continuing Professional Education (CPE) Policy.
- A maximum of \$200 per draw is available to eligible applicants per fiscal year. The fiscal year runs from March 1 to February 28.
- Applications are accepted twice per year. The deadline for receipt of applications is March 16 and September 16.

Eligibility Criteria

- Current NLASW members are eligible to apply to the NLASW Professional Development Fund.
- The educational event must occur within the same fiscal year as the application deadline.
- The educational event must meet the criteria for required credits as defined by the CPE policy.
- Members who have been successful in the previous draw will **not** be eligible for the upcoming draw; that is, members cannot receive funding for two consecutive draws.
- Members must notify NLASW if they have received funding from another source. Events fully funded by another source (e.g. employer) are not eligible.
- The completed application form with the required attachments must be submitted by the deadline for the current draw.
